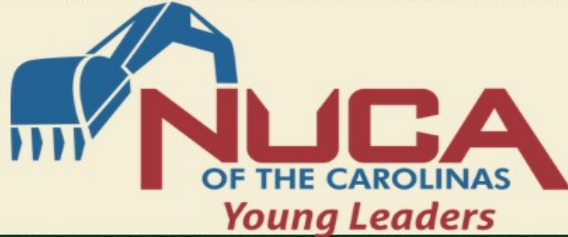

Well, fall is finally upon us! And not a moment too soon. I am looking forward to the cooler temps, the changing leaves and all the exciting things coming around the corner for NC 811!

But first the numbers. We are running at 10% volume increase over last year at this time. Around 80% of those tickets are electronic but we are starting to see busier days with longer hold times for those other 20%. Yet another reason to use our various tools to do tickets online! Meanwhile we are hoping that the new law change coming October 1 will help reduce some of the update tickets with the move to 28 calendar day ticket life from 15 working days.

At NC 811 we don't do anything halfway. Not content to just roll the new law out on October 1, we will be also launching Center Logix: the software to replace our ticket taking program. What this means for excavators is multiple things.

First we will be migrating RTE users to Center Logix users during the month. Second we will be changing how tools like Single Address Ticket (SAT) and update lite are directed: sending them through the Dig Logix portal. Third, there are new tools in the system that include electronic white lining, LLM report generation and "look over my shoulder" technology that can allow a caller to receive a link to see the map the CSR is looking at in cases where the area is not clear. This verification technique won't be used all the time but can be an additional way to improve communication.

The same can be said for attachments which can be much more easily made and viewed in the new system.

It's a lot to take in and our team is training, educating and conducting final testing to insure a smooth transition. Your patience during the transition is also greatly appreciated!

The CGA DIRT report for 2024 is out and I encourage folks to check it out and share with your employees. If nothing else it should spark a good dialog. The outcome shows that not much has changed: when excavation work increases, so do damages. Also, late locates continue to contribute to process challenges. I look forward to seeing many of you at the NUCA Carolina's fall meeting in Grove Park! In the meantime GO "whichever football team you are rooting for", stay safe and stay patient!

This year is flying by, and fall is right around the corner. September is National Preparedness Month, which makes it the perfect time to review your storm plan and stay ready as hurricane season continues.

It has been a busy few months here at SC811! Between events and the passing of bill HB3571, there has been plenty of activity. Our notifications have continued to rise throughout Dig Season. In July, we saw an 8.07% increase, followed by 6.22% in August. With the increase in work activity, we have also seen a rise in damages across the state with more than 2,000 reported since the beginning of the year. The majority of these are occurring in Greenville, Charleston, Horry, Columbia, and York Counties. This is a strong reminder of why it is so important to always contact 811 before you dig.



On July 31<sup>st</sup>, we hosted a successful Safety Summit in partnership with Berkeley Electric in Moncks Corner with 95 attendees. Thank you to everyone who participated and helped make the event a success. Shortly after, we celebrated 811 Day on August 11. Despite the rain, it was a wonderful day with support from Fort Jackson and Dominion Energy. We are grateful to everyone who attended and continue to appreciate the strong support shown at our events. To stay up to date with what is coming next, be sure to follow us on social media.

In July, we briefly mentioned the passing of HB3571. Since then, we have added more resources to our website to help explain what is ahead when the new law takes effect in May 2026. ## Industry News and Advocacy

### **Congress Returns For Appropriations Action**

Lawmakers returned to Washington this week after their month-long recess with a looming Sept. 30 deadline to fund the federal government or face a shutdown. Both the House and Senate have 14 legislative days to reach an agreement on a stopgap continuing resolution. However, with the Trump Administration's cut-backs in several sectors running into Democratic opposition, final spending agreements are not expected to be reached until the end of the year, at the earliest--and some lawmakers are already proposing a full-year continuing resolution (CR). The EPA's SRF funding remains in FY2026 legislation at about 20% lower than FY2025, but NUCA is pushing hard for it to be restored to at least full FY2025 numbers. NUCA and our industry allies continue to press Congress on the importance of increasing SRF appropriations, which have remained flat for several years.

### **Congress Returns To Begin Work on Surface Transportation, SRF Reauthorization**

As Congress reconvenes in early September 2025 after the traditional August recess, lawmakers face a packed fall agenda dominated by fiscal deadlines and infrastructure priorities. Beyond FY2026 funding, the fall Congressional session is expected to spotlight surface transportation reauthorization. The Infrastructure Investment and Jobs Act (IIJA) passed in 2021, authorizing \$550 billion for highways, transit, and rail through FY2026, nears expiration next September 30, 2026, but groundwork should begin this month.

House Transportation & Infrastructure Committee hearings this fall will emphasize streamlining permitting, bolstering Highway Trust Fund solvency amid a projected \$150 billion shortfall, and prioritizing safety and resilience. Water infrastructure looms large too, with potential reauthorization of the State Revolving Funds (SRFs). The Clean Water SRF and Drinking Water SRF, bolstered by IIJA's \$50 billion infusion, are the lifeblood of the American utility construction industry.

### **Landmark FAR Updates Announced By White House**

The federal government's Office of Federal Procurement Policy (OFPP) announced Aug. 15 several major updates to the Federal Acquisition Regulation (FAR) within its "Revolutionary FAR Overhaul" (RFO) program instituted by the Trump Administration.

This FAR overhaul--the most significant in 40 years--allows agencies to immediately remove non-critical requirements of those not grounded in statute or executive order and deemed to have minimal impact on contract performance. The OFPP also stated that agencies may "immediately begin eliminating one-third of requirements from their future contracts that are not required by statute or executive orders and have little to do with contract outcomes," and directed agencies to use government-wide contracts for common commercial products and services. The RFO initiative significantly reduces regulatory complexity and opens federal contracting to innovative small businesses and new entrants. New and seasoned federal contractors should become familiar with the revised FAR structure and prepare for ongoing changes.
